### LIABILITY WAIVER AND RELEASE

#### 1. ACKNOWLEDGEMENT OF RISK:

The Pet Owner understands and acknowledges that boarding a pet in a pet hotel involves certain inherent risks. These risks include, but are not limited to, injury, illness, or death of the pet due to accidents, infections, disease, or other factors beyond the control of the Pet Hotel. The Pet Owner further acknowledges that despite reasonable care and supervision, incidents may occur.

### 2. RELEASE OF LIABILITY:

The Pet Owner agrees to release, waive, and discharge the Pet Hotel, its owners, employees, agents, and representatives from any and all claims, demands, actions, or causes of action that arise from or are related to any injury, illness, loss, or death of the pet while the pet is under the care, custody, and control of the Pet Hotel, including but not limited to accidents, negligence, or other causes.

This release applies to all claims for personal injury, property damage, or any other loss or damage of any kind, whether foreseeable or unforeseeable, whether caused by negligence or otherwise, to the fullest extent allowed by law.

#### 3. ASSUMPTION OF RISK:

The Pet Owner assumes full responsibility for any risks associated with boarding their pet at the Pet Hotel, including but not limited to physical injury, behavior issues, aggression, illnesses, or other risks associated with placing the pet in a group or communal environment. The Pet Owner also acknowledges that the Pet Hotel may seek outside veterinary care in the event of an emergency, at the Pet Owner's expense.

### 4. EMERGENCY MEDICAL TREATMENT:

The Pet Owner authorizes the Pet Hotel to seek emergency veterinary treatment, as deemed necessary by the Pet Hotel staff, in the event of an emergency.

The Pet Hotel shall make every effort to contact the Pet Owner in any emergency situation before seeking professional veterinary treatment. In the event that the Pet Hotel does not reach the Pet Owner for consent, this authorization gives the Pet Hotel the right to act on the Pet Owner's behalf in the event a pet needs emergency medical attention.

By signing this Agreement, I, the Pet Owner, authorize a licensed veterinarian and their assistants, to administer treatment and perform procedures as are considered therapeutically and diagnostically necessary for the care of my pet, including administration of anesthesia.

In the event that emergency treatment is required, I authorize the veterinary staff and their assistants to perform medical and surgical treatments necessary to preserve the life of my pet until I can be contacted for further approval.

I accept full responsibility for any and all financial responsibility for the treatment that my pet receives from the licensed veterinarian and their staff.

I hereby release Houndstongue Pet Hotel, LLC from any and all claims from any emergency situation.

### 5. CONDITION OF PET:

The Pet Owner affirms that the pet is in good health and free from contagious diseases. The Pet Owner agrees to provide the Pet Hotel with updated vaccination records prior to drop-off, including but not limited to the following vaccinations:

- Rabies
- Distemper/Parvovirus (DAPP)
- Canine Influenza
- Bordetella (Kennel Cough)

The Pet Hotel requires proof of vaccination to ensure the health and safety of all animals in its care. If the Pet Owner fails to provide proof of current vaccinations or if the pet is not in good health, the Pet Hotel reserves the right to refuse service.

The Pet Owner agrees and understands that in admitting their pet to the Pet Hotel that their pet is in good health, is current on all vaccinations and has not harmed or shown aggression or threatening behavior towards another animal and/or human. The Pet Owner understands that in any cageless environment, there is an inherent risk of injury or illness from rough play and/or fights. Understanding this, the Pet Owner accepts full responsibility and holds Houndstongue Pet Hotel, LLC, harmless for any pet injury, death, or damage.

The Pet Owner agrees to be solely responsible for any harm caused by their pet while in the care of the Pet Hotel. The Pet Owner understands if their pet shows repeated aggressive or menacing behavior that the pet will be moved to seclusion. If the behavior continues, the pet may be asked not to return to Houndstongue Pet Hotel. By signing this Agreement, the Pet Owner acknowledges that they understand and accept the terms and conditions set forth by this Agreement.

### **6. INDEMNIFICATION:**

The Pet Owner agrees to indemnify and hold harmless the Pet Hotel, its owners, employees, agents, and representatives from any claims, demands, or causes of action arising from the Pet Owner's actions, including but not limited to the behavior of their pet, any injuries caused by their pet, or any violation of the terms of this Agreement.

#### 7. GOVERNING LAW:

This Agreement shall be governed by and construed in accordance with the laws of the State of Mississippi. Any disputes arising from this Agreement shall be resolved in the courts located in Union County, Mississippi.

# 8. SEVERABILITY:

If any provision of this Agreement is found to be invalid or unenforceable by a court of competent jurisdiction, the remainder of this Agreement shall remain in full force and effect.

# 9. ENTIRE AGREEMENT:

This Agreement constitutes the entire agreement between the Pet Owner and the Pet Hotel regarding the subject matter herein and supersedes any prior agreements or understandings, whether written or oral.
